Camping will be camporee style with troops camping near each other. Similar to other camping weekends we will cook all of our own meals, but our schedule will be interacting with the other troops.

The Camporee theme is CSI Crime Scene Investigation. The events include: .22 Cal rifle shooting, lifting fingerprints, interviewing suspects and witnesses, casting, remote evidence retrieval, working with a crime lab, processing a crime scene, K9 presentation, Decryption and ends with you requesting an arrest warrant.

Our weekend is guaranteed to be a busy one, with other events I cannot disclose at this time.

We will not be using a shelter for the weekend, so please pack accordingly. October can be cold in the mornings, so please remember to bring a coat, gloves and hat in addition to a warm sleeping bag and mat. Class A's will be required for this campout at times. When not in a Class A, scouts are required to be in a Class-B, so please bring them.

Parents, we really need you this weekend, too. A minimum of four adults are needed to walk the stations with the scouts. Any others are needed to help at the stations. Seniors, if you would rather volunteer at a station there is still availability, just let me know and I can inquire.

We may be able to get an earlier start with scouts out of school, but for now plan to be at church at 5:30 to load your gear.
